A complete set of Bidding Documents may be purchased from the office of Limchungbung Rural Municipality by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of NRs. 1000.00 till 2078/09/07 during office hours.
4. Sealed bids must be submitted to the office Limchungbung Rural Municipality, Baraha Udayapur by hand on or before 12:00 PM on 2078/09/08. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2078/09/08, 2:00 PM at the office of Limchungbung Rural Municipality, Baraha. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of Rs.50,000.00 which shall be valid for 75 days beyond the validity period of the bid. If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No. 43225240600003 at Nepal SBI Bank, Limchungbung Branch and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.

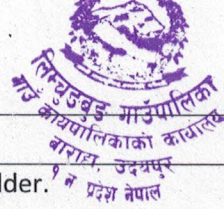

Evaluation and Comparison of Quotations	<p>21.1 In evaluating the Quotations, the Purchaser shall determine for each Sealed Quotation the evaluated Quotation Price by adjusting any corrections for errors. Quotations shall be checked by the Purchaser for any arithmetic errors.
