- 1. The Limchungbung Rural Municipality invites sealed electronic bids for the construction work shown in table below under National Competitive Bidding procedures.
- 2. Bidders interested to bid have to download the bidding documents from PPMO's e-GP system www.bolpatra.gov.np/egp and submit electronically. The bidders submitting their bid electronically should deposit the cost of biding document NRs. 3,000/- (non-refundable) fee in Sanchit Kosh Account No.43295241207001 of Nepal SBI Bank, Limchungbung Branch - Udayapur and submit bank deposit voucher along with the electronic bid files.
- 3. Bids must be submitted electronically only through www.bolpatra.gov.np, on or before 12:00 noon on 2076/12/25.

Documents received after this deadline shall not be accepted.

- 4. Bids will be opened in the presence of Bidders' representatives who choose to attend at 14.00 PM on 2076/12/26 at the office of Limchungbung Rural Municipality. Bids must be valid for a period of 90 days after bid opening and must be accompanied by bid security, amounting to a minimum of shown in table below (inclusive of VAT), which shall be valid for 30 days beyond the bid validity period.
- 5. If bidder wishes to submit the Bid security fee in the form of cash, bidder has to deposit cash in Dharauti Khata Account No. 43225240600003 of Nepal SBI Bank, Limchungbung Branch -Udayapur and submit bank deposit voucher along with the electronic bid files.
- If the last date of purchasing, submission and opening falls on a government holiday then the next 6. working day shall be considered as the last day.
- The Employer reserves the right to accept or reject, wholly or partly any or all the bids without 7. assigning any reason, whatsoever.
